- TO STATE AND RULE that by reproducing LUVANIS documentation without authorisation, CREATIVE CAPITAL, Mr Louis HOUDART, JOY UNIVERSAL Limited and STAR ASSET INTERNATIONAL Limited were guilty of infringement of copyright for the reproduction of LUVANIS documents, as defined by articles L.122-4 and L.335-3 of the Intellectual Property Code;

Consequently:

- TO ORDER in solidum the Defendants to pay a total of fifty thousand (50,000) Euros;
- TO PROFIBIT CREATIVE CAPITAL, Mr Louis HOUDART, JOY UNIVERSAL Limited and STAR ASSET INTERNATIONAL Limited from reproducing, in any format whatsoever, and subject to a penalty of 1,000 Euros per infringement observed following handing down of the ruling, any wording or excerpt of wording included in the LUVANIS documentation;
- TO ORDER the destruction of any support or digital file held directly or indirectly by CREATIVE CAPITAL, Mr Louis HOUDART, JOY UNIVERSAL Limited or STAR ASSET INTERNATIONAL Limited reproducing any wording or excerpt of wording from the LUVANIS documentation, and subject to a penalty of 1,000 Euros per day of penalty, with said penalties to be paid by the Court;
- * TO STATE AND RULE that CREATIVE CAPITAL is contractually liable towards LUVANIS, pursuant to article 1134 of the Civil Code and article 1984 of the Civil Code;

Consequently:

- TO ORDER CREATIVE CAPITAL to pay a total of one hundred thousand (100,000) Euros;

- TO ORDER publication, in extenso or in excerpts, of the ruling to be handed down under the header "Legal Warning" in eight French or foreign journals at the choice of LUVANIS, and up to a maximum amount of 6,000 Euros excluding tax per publication to be payable by CREATIVE CAPITAL, Mr Louis HOUDART, JOY UNIVERSAL Limited and STAR ASSET INTERNATIONAL Limited in solidum;
- TO ORDER provisional enforcement of the decision, notwithstanding appeal and without security;
- * TO ORDER in solidum CREATIVE CAPITAL, Mr Louis HOUDART, JOY UNIVERSAL Limited and STAR ASSET INTERNATIONAL Limited to pay LUVANIS a total of €20,000 pursuant to the provisions set forth under article 700 of the Civil Procedure Code;
- * TO ORDER in solidum CREATIVE CAPITAL, Mr Louis HOUDART, JOY UNIVERSAL Limited and STAR ASSET INTERNATIONAL Limited to pay LUVANIS all costs for proceedings pursuant to the provisions set forth under article 699 of the Civil Procedure Code, which may be collected by Maître Thibault LANCRENON.
