TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 22, 2014 ("Release"), is made by CIT Healthcare LLC, as Second Lien Agent, a Delaware limited liability company ("Second Lien Agent"), in favor of Amenity Healthcare, Inc., a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Second Lien Security and Pledge Agreement dated as of November 30, 2006 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantor, Second Lien Agent, and others party thereto and the Second Lien Trademark Security Agreement dated as of November 30, 2006 ("Trademark Security Agreement") by and among the Grantor and Second Lien Agent, Grantor granted to the First Lien Agent, for the benefit of Second Lien Agent, a security interest in all of Grantor's right, title and interest in, to and under the Trademark First Lien; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on August 28, 2008 at Reel 3850 Frame 0323 and errantly recorded on August 28, 2008 at Reel 3844 Frame 0303.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Second Lien Agent and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Second Lien Agent, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the Grantor's right, title, and interest in, to, and under the Trademark First Lien, including, but not limited to, the foregoing listed on Schedule A attached hereto; and


(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
