TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 22, 2014 ("Release"), is made by CIT Healthcare LLC (f/k/a Healthcare Business Credit Corporation), a Delaware limited liability company ("Lender"), in favor of Amenity Healthcare, Inc., a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of September 19, 2003 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantor, Lender, and others party thereto and the Patents, Trademarks, Copyrights, and Licenses Security Agreement (Trademarks) dated as of September 30, 2005 ("Trademark Security Agreement") by and among the Grantor and Lender, Grantor granted to the Lender a lien and security interest in all of Grantor's right, title and interest in the Assets (as defined in the Trademark Security Agreement); and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on October 13, 2005 at Reel 3174 Frame 0439.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the Grantor's right, title, and interest in the Assets, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New Jersey.
