## AFFIDAVIT


I, the undersigned Richard W. Young, Illinois bar member and counsel for Assignee, having firsthand knowledge regarding the ownership of the PREDATOR United States trademark registration No. 2757221 ("Mark") solemnly and sincerely declares as follows:

1. The assignment document dated March 1, 2007 transferring ownership of the Mark from Prima Instrument Co. ("Assignor") to Prima Dental Group ("Assignee") inadvertently listed the Assignee as Prima Dental Group rather than Prima Dental **Manufacturing**.
2. Prima Dental Group is not a legal entity but is in fact merely a trade name of Prima Dental Manufacturing.

Assignee respectfully requests that the identity of the assignee in the United States Patent and Trademark Office assignment records be corrected so as to name the legal entity, Prima Dental Manufacturing, a United Kingdom corporation, rather than the trade name of that entity. *See* T.M.E.P. § 503.06(b) (permitting correction of errors in recorded assignment documents); *see also*, T.M.E.P. § 1201.02(c) ("If an applicant identifies itself by a name under which it does business, which is not a legal entity, then amendment to state the applicant's correct legal name is permitted").
