of said Assignee or nominee to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.

Assignor hereby covenants with said Assignee, its successors, assigns and legal representatives, that, notwithstanding and other than as provided in that certain License and Sale Agreement to be entered into by and between Assignor and Frederick P. Schall, Inc., the rights and property herein conveyed are free and clear of any encumbrance, and that Assignor has full right to convey the same as herein expressed.


