TRADEMARK ASSIGNMENT

NOW THEREFORE, for the sum of USD \$10.00, paid by Assignee, and other good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged, Assignor, by these presents does hereby sell, assign and transfer unto Assignee all of Assignor's right, title and interest in and to the Trademark, together with all the associated goodwill of the business symbolized by the Trademark, and all applications and registrations of the Trademark, as well as all rights to injunctive relief, damages, and profits, due or accrued, arising out of all causes of action, past, present, and future, including infringement of the Trademark, or other violations, or injury to the said goodwill, and the right to sue for and recover the same in Assignee's own name and the names of Assignee's successors, assigns, or other legal representatives; the same to be held and enjoyed by said Assignee for its own use, and for its legal representatives and assigns, as fully and entirely as the same would have been held by Assignor had this Trademark Assignment not been made.

Assignor agrees that it will do all such things and execute all such documents as may be necessary or desirable to apply for, obtain and/or maintain the Trademark and for modifications thereto worldwide, and to vest title thereto in Assignee, its successors, assigns and legal representatives or nominees.

Assignor hereby authorizes and requests recognition, including by any relevant intellectual property office Commissioner, of Assignee's rights, as the assignee of Assignor's entire rights, title and interest in and to the Trademark, of sole use and benefit of the Trademark, and for the use and benefit of its successors and assigns, to the full end of the term for which

rights in the Trademark may be granted as fully and entirely as the same would have been held by Assignor had this assignment not been made.
