RELEASE OF SECURITY AGREEMENT

THIS RELEASE OF SECURITY AGREEMENT dated as of January [7], 2015, is made by First National Bank Southwest (a branch of First National Bank of Omaha), a National Banking Association ("Lender").

WHEREAS, Lender and Parago, Inc., a Delaware corporation ("Debtor"), are parties to that certain: (i) Loan Agreement, dated as of December 24, 2004 (as the same may be amended, restated, modified, or supplemented from time to time, the "Loan Agreement"); (ii) Security Agreement dated as of December 24, 2004 (as the same may be amended, restated, modified, or supplemented from time to time, the "Security Agreement"), which was recorded in the United States Patent and Trademark Office on February 10, 2005 at Reel/Frame 016246/0801 against the patents identified on Schedule I and in the United States Copyright Office on February 11, 2005 as Recorded Document Number V3520D663 against the copyright registrations identified on Schedule I; (iii) Amended and Restated Loan Agreement dated as of December 6, 2006 (as the same may be amended, restated, modified, or supplemented from time to time, "Amended and Restated Loan Agreement"); (iv) Ratification and Confirmation of Security Agreement dated as of December 6, 2006 (the "Ratification"); and (v) Intellectual Property Security Agreement dated as of February 20, 2007, which was recorded in the United States Patent and Trademark Office on March 8, 2007 at Reel/Frame 018983/0113 against the patents identified on Schedule I and at Reel/Frame 3496/0292 against the trademark identified on Schedule I (as the same may be amended, restated, modified, or supplemented from time to time, the "Intellectual Property Security Agreement").

WHEREAS, the Security Agreement and the Intellectual Property Security Agreement granted, assigned and conveyed to Lender a security interest in Lender's entire right, title and interest in and to all of its intellectual property collateral (as defined in the Security Agreement and the Intellectual Property Security Agreement), including, without limitation all of the patents, trademarks and copyrights listed on Schedule I.

WHEREAS, Lender desires to release its rights and security interests in all intellectual property collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the intellectual property collateral, including, without limitation, all of the patents, trademarks and copyrights listed on Schedule I and (ii) any and all other rights it may have under the Security Agreement or the Intellectual Property Security Agreement.

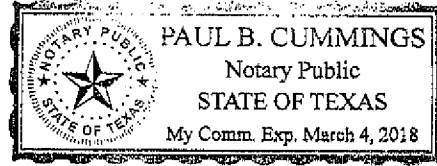
