OF GRANT OF SECURITY INTEREST (TRADEMARKS)**

TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS) (“Release”), dated as of February 5, 2015, by **WEBSTER BANK, NATIONAL ASSOCIATION**, a national association (the “Administrative Agent”), in favor of **CSDVRS, LLC**, a Delaware limited liability company (the “Company”).

WHEREAS, pursuant to the terms of that certain Grant of Security Interest (Trademarks) (the “Agreement”), dated as of June 25, 2013, by the Company in favor of the Administrative Agent, the Company granted to the Administrative Agent a security interest in and to all of the right, title and interest of the Company in and to the Trademark Collateral (as defined in the Agreement), including, without limitation, the trademarks listed on Schedule A attached hereto (collectively, the “Trademarks”), and which trademarks listed on Schedule A are registered in the United States Patent and Trademark Office, together with all registrations thereof, the goodwill of the business symbolized by the Trademarks and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (the “Collateral”), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement (defined in the Agreement)); and

WHEREAS, the Administrative Agent wishes to terminate and release its security interest in and to all of the right, title and interest of the Company in and to the Collateral; and

WHEREAS, the Agreement was filed on July 2, 2013 with the United States Patent and Trademark Office in Reel: 5061; Frame: 0956,


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges fully its security interest in and to all of the right, title and interest of the Company in and to the Collateral, and reassigns and transfers to the Company all right, title and interest that the Administrative Agent may have in the Collateral, and terminates the Agreement. The Administrative Agent hereby authorizes the Company, or the Company’s authorized representative, to record this Release with the United States Patent and Trademark Office.
