TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration set forth in the Agreement, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby assigns, transfers, and sets over to Assignee all of Assignor's right, title, and interest in and to the Trademarks and associated goodwill, including the right to sue for and receive all damages from past infringements of the Trademarks, the same to be held and enjoyed by Assignee, its successors, assigns, and other legal representatives. Assignor shall, at its own cost and expense, execute and deliver any and all instruments and documents and take such further actions as may be necessary or reasonably requested by Assignee to document and record with the appropriate authorities, if applicable, the aforesaid assignment and transfer, provided that Assignee shall be solely responsible for filing and recording such documents.


This Assignment may be executed in counterparts, including by facsimile or PDF, each of which will be deemed an original, but all of which together constitute one and the same original.
