**REASSIGNMENT AND RELEASE OF SECURITY INTEREST –
TRADEMARKS**

This Reassignment and Release of Security Interest (this “Release”) is made as of March 2, 2015 by FIFTH THIRD BANK, an Ohio banking corporation (“Secured Party”), in favor of TOWNE AIR FREIGHT, LLC, an Indiana limited liability company (the “Debtor”).

Recitals

WHEREAS, the Debtor received certain financial accommodations from the Secured Party, and in connection therewith entered into a Trademark Security Agreement dated as of March 24, 2014 (as amended or modified or amended and restated from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Debtor pledged, assigned, and granted to the Secured Party a security interest in the trademarks and trademark applications identified on Schedule 1 to this Release (collectively, the “Trademarks”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 5264/0013 on April 18, 2014;

WHEREAS, the Debtor has paid a substantial portion of the indebtedness owing to the Secured Party; and

WHEREAS, the Secured Party wishes to reassign to Debtor and release all interest that Secured Party may have in the Trademarks.

Agreement

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party terminates, releases, and discharges any and all security interest in the Trademarks, and reassigns to Debtor, without recourse, representation, or warranty, all interest of Secured Party in the Trademarks.
