2. The following amendments to the Certificate of Incorporation were adopted by unanimous consent of shareholders and directors as of August 28, 2014:

Article First is hereby deleted in its entirety and replaced with the following new Article First:

3. ~~FIRST~~: The name of the Corporation is Navitas, Inc.
4. The number of shares of the Corporation entitled to vote on the amendment is 32,400,000 shares of common stock without par value.
5. The number of shares of common stock voted for the amendment is 32,400,000. The number of shares voted against the amendment is zero.
