NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT

1 Assignment

1.2 Assignment – Melt Shop hereby assigns to Little Beet, and Little Beet accepts, all right, title and interest to the Subject Marks, including all goodwill associated therewith. Without limiting the foregoing, the assignment includes the entirety of the portion of the business to which the marks pertain.

1.3 Effective Date – This agreement and the assignment contained herein is effective, nunc pro tunc as of June 11, 2013.

2 Miscellaneous Provisions

2.1 This Agreement will be governed by the laws of the State of New York without reference to its choice of laws provisions. The parties to this Agreement hereby agree to submit to the jurisdiction of the Courts of The State of New York and United States Courts located therein for actions arising out of this Agreement or breach thereof.

2.2 This Agreement constitutes the entire understanding between the parties and supersedes any and all prior and contemporaneous, oral or written representations, communications, understandings and agreements between the parties with respect to the subject matter of this Agreement.




2.4 This Agreement will not be modified except by written instrument signed by both parties hereto.
