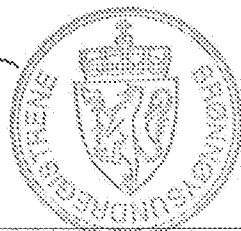

The merger has been carried out in accordance with the provisions in the Norwegian Share Act chapter 13.

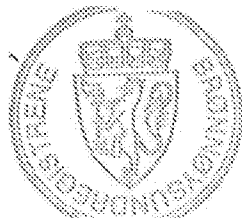
