PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS dated March 25, 2015, by Fifth Third Bank, an Ohio banking corporation with its mailing address at 38 Fountain Square Plaza, Cincinnati, Ohio 45263 (“*Fifth Third*”), acting as administrative agent hereunder for the Secured Creditors as defined in the Agreement referred to below (Fifth Third acting as such administrative agent being hereinafter referred to as the “*Administrative Agent*”);

WITNESSETH:

WHEREAS, Radio Systems Corporation, a Delaware corporation (“*Debtor*”), with its mailing address at 10427 PetSafe Way, Knoxville, TN 37932, and Administrative Agent were parties to that certain Trademark Collateral Agreement dated October 28, 2010, between Debtor and Administrative Agent which was recorded in the United States Patent and Trademark Office on November 1, 2010, at Reel 4308, Frame 0148 (the “*Agreement*”), pursuant to which Debtor granted to Administrative Agent, a security interest in, among other things, the trademarks listed on Schedule A attached hereto and certain other property (collectively, the “*Trademark Property*”); and

WHEREAS, Debtor has requested that Administrative Agent release its security interests in the Trademark Property;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Administrative Agent hereby releases its security interests in, without any representation, warranty, recourse or undertaking by Administrative Agent, all of its right, title and interest, if any, in and to each trademark listed on Schedule A hereto, including:


- (i) Each trademark listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark; and
- (ii) All proceeds of the foregoing, including without limitation any claim against third parties for damages by reason of past, present or future infringement of any trademark listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, in each case together with the right to sue for and collect said damages.

THIS IS A PARTIAL RELEASE ONLY; EXCEPT AS TO THE TRADEMARK PROPERTY SPECIFICALLY RELEASED HEREBY, THE SECURITY INTEREST OF THE ADMINISTRATIVE AGENT PURSUANT TO THE AGREEMENT IN EACH AND EVERY OTHER TRADEMARK AND TRADEMARK APPLICATION CONTINUES IN FULL FORCE AND EFFECT TO THE SAME EXTENT AS IF THIS PARTIAL RELEASE AND REASSIGNMENT OF TRADEMARKS HAD NOT BEEN FILED.
