**RELEASE OF IP  
SECURITY INTEREST AGREEMENT**

This Release of IP Security Interest Agreement (this "Release") is conveyed as of March 3, 2015, by COMERICA BANK, as Agent for itself and other Lenders under the Security and Pledge Agreement referred to below (in such capacity, the "Agent"), in favor of Ox Bodies, Inc., an Alabama corporation ("Ox"), Rugby Manufacturing Company, an Oregon corporation ("Rugby"), Crysteel Manufacturing, Inc., a Minnesota corporation ("Crysteel"), and Tishomingo Acquisition, LLC, a Delaware limited liability company ("Tishomingo" and together with Ox, Rugby and Crysteel, collectively, the "Debtors").

WHEREAS, the Agent, Ox and Rugby executed a Security and Pledge Agreement, dated July 19, 2005 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the "Original Security Agreement"), which was recorded with the United States Patent and Trademark Office (the "USPTO") on August 24, 2005, at Reel 003146 Frame 0432, under which the Ox and Rugby granted to the Agent a security interest in (i) each respective Debtor's interest in the patents and patent applications listed on the attached Schedule A (the "Patents") and (ii) each respective Debtor's interest in the trademark registrations and the trademark applications listed on the attached Schedule A (collectively, the "Original Trademarks") and the goodwill associated therewith.

WHEREAS, Crysteel executed a Joinder Agreement, dated as of December 23, 2005 (the "Crysteel Joinder"), to the Original Security Agreement in favor of the Agent, which was recorded with the USPTO on January 11, 2006, at Reel 003225, Frame 0189, under which Crysteel granted to the Agent a security interest in its interest in the trademark registrations and the trademark applications listed on the attached Schedule B (collectively, the "Crysteel Trademarks") and the goodwill associated therewith.


WHEREAS, Tishomingo executed a Joinder Agreement, dated as of August 30, 2006 (the "Tishomingo Joinder" and together with the Original Security Agreement and the Crysteel Joinder, collectively, the "Security Agreement"), to the Original Security Agreement in favor of the Agent, which was recorded with the USPTO on October 4, 2006, at Reel 003402, Frame 0116, under which Tishomingo granted to the Agent a security interest in its interest in the trademark registrations and the trademark applications listed on the attached Schedule C (collectively, the "Tishomingo Trademarks" and together with the Original Trademarks and the Crysteel Trademarks, the "Trademarks") and the goodwill associated therewith.

WHEREAS, the Agent wishes to release, retransfer and reassign to each Debtor, without representation or warranty, all of the Agent's right, title and interest in and to the Trademarks and the goodwill associated therewith, and the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Agent hereby releases, retransfers and reassigns to each Debtor, without representations or warranty, all of the Agent's right, title and interest in and to the Trademarks and the goodwill associated therewith, and the Patents.
