## RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Release") is made by and between **NANOFILM, LTD.**, an Ohio limited liability company ("Pledgor") and **FIFTH THIRD BANK**, an Ohio banking corporation ("Bank") concerning an Intellectual Property Security Agreement dated July 30, 2013 ("Note"), in which to secure obligations of Pledgor under the Note, Pledgor granted to Bank a security interest in the Collateral, set forth in Schedule A. (Capitalized terms which are not defined herein shall have the meanings ascribed thereto in the Note.)

WHEREAS, Pledgor has fulfilled its financial obligation to Bank and there is no loan outstanding between the parties, and the parties have agreed to terminate the Note as of the date of April 22, 2014.

NOW THIS RELEASE WITNESSETH that:

1. The Note shall be terminated as of April 22, 2014.
2. As of the date of this Release, Bank hereby unconditionally and irrevocably RELEASES the security interest in the Collateral and DISCHARGES Pledgor from all its past, present and future (actual or contingent) liabilities to Bank under the Note, including any liability with respect to the Collateral. Upon the execution of this Release, the Collateral shall be absolutely freed and discharged of and from Bank's security interest as provided in the Note.
3. Bank further undertakes and agrees to do all acts and things and/or execute any further documents as Pledgor may reasonably request to carry into effect or to give legal effect to the provisions of this Release.
4. This Release may not be changed except in a writing signed by the party against whose interest such change shall operate. This Release shall be governed by and construed under the laws of the State of Ohio without regard to principles of conflicts of law.

IN WITNESS WHEREOF, Bank has caused this Release to be duly executed by their respective officers or agents thereunto duly authorized, as of the date first above written.
