Smithfield Farmland hereby covenants, agrees and promises to undertake to execute, whenever requested by Jonmor, all trademark applications, trademark registrations, assignments, lawful oaths, and any other papers which Jonmor may deem necessary or desirable for securing to

Jonmor, or for maintaining unto Jonmor, all rights hereby confirmed as assigned, assigned, or agreed to be assigned, all without further compensation to the undersigned Smithfield Farmland.
