RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE of Intellectual Property Security Agreement (“Release of IP Security”) is executed as of March 3rd, 2015, by Morgan Stanley Bank International Limited (the “Agent”), for the benefit of Spectrum Dynamics LLC (the “Grantor”).

WHEREAS, reference is made to (i) the Senior PIK Term Loan Agreement, dated as of November 25, 2008, by and among, *inter alios*, MedInvest Capital S.à r.l., a private limited liability company (*société à responsabilité limitée*), incorporated under Luxembourg law, with registered office at 231, Val des Bons Malades, L-2121 Luxembourg-Kirchberg, registered with the Luxembourg trade and companies register under number B142931 and having a share capital of EUR 12,500 as borrower (“MedInvest”), and the Agent, as amended and supplemented from time to time (the “Senior Facility Agreement”). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to such terms in the Senior Facility Agreement;

WHEREAS, pursuant to an IP Security Agreement, dated as of March 9, 2009 (the “IP Security Agreement”), between the Grantor, MedInvest, as pledgee, and the Agent, which IP Security Agreement was recorded in the U.S. Patent and Trademark Office (the “Office”) on March 18, 2009 at Reel: 003954, Frame: 0862 and on March 18, 2009 at Reel: 22448 Frame: 833, the Grantor has granted a security interest in its right, title and interest in and to the intellectual property listed in Annex 1 hereto (the “Intellectual Property”) to MedInvest;

WHEREAS, pursuant to the terms of that certain Portfolio Company Assignment Agreement, dated as of March 9, 2009, between MedInvest and the Agent, MedInvest has assigned all of its rights and interests in the Intellectual Property to the Agent for the benefit of the Secured Parties; and


WHEREAS, in connection with the discharge of all liabilities and obligations of the Grantor under the PC Documents, in relation to the Grantor, the Agent has agreed to release the security interests created under the IP Security Agreement as of the date hereof on the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases the security interests over the Intellectual Property created by the IP Security Agreement as of the date first written above.
