## RELEASE OF TRADEMARK SECURITY INTEREST

This **RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of April 3, 2015 (this "Release"), is made by Medley Capital Corporation, as collateral agent ("Secured Party"), in favor of ARBOC Specialty Vehicles, LLC, a Delaware limited liability company ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of March 21, 2013 and recorded with the United States Patent and Trademark Office on April 11, 2013 at Reel/Frame 5004/0551 (as amended, amended and restated, supplemented or otherwise modified, the "Trademark Security Agreement"), made by Grantor in favor of the Secured Party, Grantor pledged and assigned to Secured Party, a first priority security interest in the trademarks listed on Schedule 1 attached hereto (collectively, the "Trademarks"), together with, among other things, the Trademark Collateral (as defined in the Trademark Security Agreement).

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby (i) terminates the Trademark Security Agreement, (ii) releases, without any representation, recourse or undertaking by Secured Party, any and all liens on and security interests in Grantor's Trademark Collateral granted pursuant to the Trademark Security Agreement, including the Trademark Collateral listed on Schedule 1 hereto and (iii) reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Secured Party, all of Secured Party's right, title and interest, if any, in and to Grantor's Trademark Collateral granted pursuant to the Trademark Security Agreement, including the Trademark Collateral listed on Schedule 1 hereto.

Secured Party shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), at the expense of Grantor and requested by Grantor to more fully and effectively effectuate the purposes of this Release.
