WHEREAS Assignee wishes to acquire Assignor's ownership rights in the subject Mark;

NOW, THEREFORE, for good and valuable consideration, Assignee agrees to pay the Assignor \$5,000 USD, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns unto Assignee, the entire right, title and interest in the Territory in and to the subject Mark, together with the goodwill of the business relating to the Mark as used in the Territory, the income and damages hereafter due or payable to Assignor with respect to the Mark in the Territory, and all rights to sue for past, present, and future infringements or misappropriations of the Mark in the Territory. Assignor further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Mark in the Territory.
