**TRADEMARK ASSIGNMENT FROM HIND HEALTH CARE, INC,  
TO ENDO PHARMACEUTICALS INC.**

WHEREAS, Hind Health Care, Inc. ("Assignor") and Endo Pharmaceuticals, Inc. (Assignee) believe that Assignor is the sole and exclusive owner of certain registered trademarks in the United States, Canada, and Mexico for the word, LIDODERM ("Trademarks"), the identities of which Assignee has assembled and set forth in Schedule A attached hereto and made a part hereof, as well as the trademark registrations associated with the Trademarks ("Registrations");

WHEREAS, Assignor and Assignee believe that Assignor is the sole and exclusive owner of a certain trademark application for LIDODERM that is pending in Mexico ("Pending Application"), which Assignee has identified and set forth in Schedule B attached hereto and made a part hereof;

WHEREAS, Assignor and Assignee believe that Assignor is the sole and exclusive owner of an inactive (abandoned) application for LIDODERM that was previously filed in Canada ("Abandoned Application"), which Assignee has identified and set forth in Schedule C attached hereto and made a part hereof;

WHEREAS, Assignor and Assignee believe that Assignor is also the sole and exclusive owner of two (2) expired and/or cancelled trademark registrations for LIDODERM in Mexico ("Cancelled Registrations"), which Assignee has identified and set forth in Schedule D attached hereto and made a part hereof;

WHEREAS, pursuant to that certain Settlement and General Release Agreement ("Settlement Agreement"), dated as of the date hereof, entered into by and between Assignor and Assignee, Assignor agreed to assign to Assignee all rights, title, and interest in and to the Trademarks, the Registrations, the Pending Application, the Abandoned Application, and the Cancelled Registrations, including, but not limited to, any and all common law rights that Assignor may have in the foregoing, and as a condition of the Settlement Agreement Assignor is executing and delivering this Assignment to transfer, assign, and set over unto Assignee and its successors and assigns all rights, title, and interest in and to the Trademarks, the Registrations, the Pending Application, the Abandoned Application, and the Cancelled Registrations;

WHEREAS, pursuant to the Settlement Agreement, dated as of the date hereof, entered into by and between Assignor and Assignee, Assignor represented to Assignee that, as of the Effective Date of the Settlement Agreement, neither Jane Hind, Leslie Daniels, nor Betsy Kais is aware of any third party claims that would challenge or impair the rights being assigned by assignor to assignee pursuant to the Settlement Agreement or this Trademark Assignment. Hind makes no other representation, warranty or guaranty whatsoever, express or implied, regarding the Trademarks, the Registrations, the Pending Application, the Abandoned Application, or the Cancelled Registrations;

NOW, THEREFORE, Assignor, in consideration of the mutual promises set forth in the Settlement Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby transfers, assigns, and sets over unto Assignee and its

successors and assigns, and Assignee hereby accepts the transfer and assignment of, all rights, title, and interest in, to and under the Trademarks, the Registrations, the Pending Application, the Abandoned Application, and the Cancelled Registrations, together with the goodwill of the business associated therewith and which is symbolized thereby, all common law rights in the Trademarks, the Registrations, the Pending Application, the Abandoned Application, and the Cancelled Registrations, all income, royalties, damages, and/or payments due or payable in respect of the Trademarks as of the date hereof or thereafter (including damages and payments for past, present, or future infringements or misappropriations thereof), including, but not limited to, all rights to sue and recover for any past, present, or future infringements, misappropriations, or violations of the Trademarks, the right to file applications for and secure registrations thereof and to renew, maintain, abandon, or otherwise control any Trademarks and any and all associated registrations and renewals thereof (including the Registrations), in the United States of America, Canada, and Mexico, the same to be held and enjoyed by the Assignee and its successors and assigns, as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment not been made. Assignor confirms that by this instrument Assignee and its successors and assigns shall own the entire right, title, and interest in and to the Trademarks, the Registrations, the Pending Application, the Abandoned Application, and the Cancelled Registrations, and all goodwill associated therewith. Assignor agrees to execute any and all additional documents and take all commercially reasonable measures that may be necessary (or may become necessary) to effectuate this Assignment of Assignee's right, title and interest in and to the Trademarks, the Registrations, the Pending Application, the Abandoned Application, and the Cancelled Registrations, and to do so without any additional compensation or consideration.
