## ASSIGNMENT OF TRADEMARKS

WHEREAS, Schlumberger Technology Corporation ("Assignor"), is the owner of the trademarks and the associated applications and registrations identified in Schedule "A" attached hereto (the "Assigned Trademarks");

WHEREAS, Assignor is an affiliate of Schlumberger Canada Limited, a company formed under the laws of Alberta ("SCL")

WHEREAS, Assignor and Nova Metrix Ground Monitoring (Canada) Ltd., whose registered office is at Suite 1700, Park Place, 666 Burrard Street, Vancouver, British Columbia, Canada, V6C 2X8 ("Assignee"), each executed an Asset Purchase Agreement, dated as of March 13, 2015, (the "Purchase Agreement"), providing for the sale of certain assets, including the Assigned Trademarks, from Assignor and certain of its affiliates to Assignee, and requiring that Assignor execute this Assignment;

WHEREAS, Assignee is desirous of acquiring all right, title and interest to the Assigned Trademarks and all of their associated goodwill;

NOW THEREFORE, for good and valuable consideration, including the execution of the Purchase Agreement by Assignor and Assignee, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor confirms the sale of the Assigned Trademarks pursuant to the terms and conditions of the Purchase Agreement, and hereby sells, assigns and transfers to Assignee, its assigns and successors, the entire right, title and interest in and to Assigned Trademarks, together with all of the goodwill attaching to the Assigned Trademarks, the same to be held and enjoyed by Assignee as fully and completely as the same could have been held and enjoyed by the Assignor if this assignment had not been made, including the assignment of the right to take action and recover for damages, profits and costs arising from any past, present and future infringements of the Assigned Trademarks, and the right to oppose any application to register a trademark which may be confusingly similar to one of the Assigned Trademarks.
2. Further Assurances. Assignor further agrees, from time to time, to make, do, and execute, or cause to be made, done, or executed all such further acts, deeds, assurances, or things that may reasonably be required to give effect to the foregoing provisions.

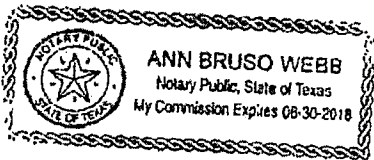


