TO THE IOWA SECRETARY OF STATE:

Pursuant to Iowa Code Sections 489.1008 and 490.1113, the undersigned, Outcomes Pharmaceutical Health Care, LLC (the "Converting Entity"), elects to convert to an Iowa corporation to be known as Outcomes Incorporated (the "Corporation") and adopts the following Articles of Conversion.

1. The Converting Entity was first formed in the State of Iowa on January 7, 1999.
2. The Converting Entity immediately prior to the Effective Date (defined below) was Outcomes Pharmaceutical Health Care, LLC, an Iowa limited liability company.
3. Upon the Effective Date, the Converting Entity shall be converted to Outcomes Incorporated, an Iowa corporation.
4. The conversion shall be effective upon the later of January 1, 2012 or the date of the filing of these Articles of Conversion and the Corporation's Articles of Incorporation with the Iowa Secretary of State (the "Effective Date").
5. The conversion of the Converting Entity to the Corporation was approved as required by Chapters 489 and 490 of the Iowa Code.
