**TRADEMARK ASSIGNMENT AGREEMENT**

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment"), effective as of May 26, 2015, is made and entered into by and between Big Method, LLC, an California limited liability company ("Big Method"), and Blitz Digital Studios, LLC, a California limited liability company ("Blitz"). Big Method and Blitz hereby agree as follows:

1. **Assignment.** Pursuant to the Asset Purchase Agreement dated August 1, 2011 between the parties, Big Method hereby irrevocably assigns, transfers and contributes to Blitz all of Big Method's right, title and interest in and to the trademarks ("Trademarks") listed on Schedule A attached to this Assignment, together with any and all goodwill associated with the Trademarks, and all rights, credits, judgments, causes of action, rights of set-off and any and all other claims of every type and nature of, for or arising from or relating to past, present or future infringement, disparagement or claims for royalties, and any and all other rights to enforce or protect any rights relating to the Trademarks, with the right to sue for such damages, and collect the same for its own use and enjoyment.

2. **Additional Actions.** At any time after the date of this Assignment, Big Method will execute and deliver to Blitz such other instruments and documents, and take such other actions as Blitz may reasonably deem necessary or desirable to effect, evidence, record and perfect the transfer and assignment contemplated by this Assignment.

3. **Representations and Warranties.** Big Method represents and warrants that as of the effective date of the Asset Purchase Agreement executed by the parties it owned all right, title and interest in the Trademarks, and Big Method has the right, power and authority to enter into this Agreement.

4. **Successors and Assigns.** This Assignment will be fully binding upon, inure to the benefit of and be enforceable by the parties and their respective successors and assigns.
