## **RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this "Release") is made as of June 8, 2015, by Citicorp North America, Inc., in its capacity as collateral agent (the "Collateral Agent") pursuant to that certain U.S. Security Agreement, dated as of August 1, 2006 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "Security Agreement"), in favor of Commonwealth Industries, Inc., a Delaware corporation (the "Grantor"). Capitalized terms used herein have the meanings attributed thereto in the Security Agreement unless otherwise defined herein.

**WHEREAS**, the Grantor and the Collateral Agent entered into that certain Grant of Security Interest in United States Trademarks, dated as of August 1, 2006 (the "Trademark Security Agreement"), whereby Grantor granted to the Collateral Agent a security interest in all of Grantor's right, title and interest in and to (i) the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same (the "Released Collateral");

**WHEREAS**, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on August 30, 2006 at Reel 3380, Frame 0691;

**WHEREAS**, in accordance with the Trademark Security Agreement, the Grantor has requested and the Collateral Agent has agreed to release, discharge, relinquish, terminate and dissolve its security interest in all of the Grantor's right, title and interest in and to the Released Collateral;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its security interest in the Released Collateral, and any right, title or interest of the Collateral Agent in such Released Collateral is hereby void.
2. Further Assurances. The Collateral Agent agrees to execute and deliver to Grantor any and all further documents and instruments, and do any and all further acts which Grantor (or its agents or designees) reasonably requests (at Grantor's sole cost and expense) in order to confirm this Release.
3. Recordation of Release. The Collateral Agent hereby authorizes Grantor or Grantor's authorized representative to record this Release with the U.S. Patent and Trademark Office.
4. Electronic Execution. This Release may be executed by facsimile transmission or other electronic transmission.
