## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Assignment") is entered into *nunc pro tunc* as of February 18, 2014, by and between Sensei, Inc., a corporation organized and existing under the law of the State of Delaware (hereinafter "Assignor"), having its principal place of business at 2300 Glades Road, Suite 220, West Boca Raton, Florida 33431, and Sensei, LLC, a limited liability company organized and existing under the law of the State of Florida (hereinafter "Assignee"), having its principal place of business at 2600 South Shore Blvd., Suite 300, League City, Texas 77573.

WHEREAS, Assignor is the sole owner of the entire right, title and interest in and to the standard character mark SENSEI, including the U.S. Trademark Registration No. 3548350, which is used in connection with "*computer software for generating wireless content delivery in the field of personal behavioral change and personal health and wellness, and presenting such information and messages via a wireless mobile device*" in Class 009, "*electronic transmission of messages and data, namely, communicating personal behavioral change and personal wellness management information via a wireless mobile device*" in Class 038, and "*providing wellness services, namely, providing personal assessments of health and wellness programs for individuals, maintenance schedules relating to individual behavior and providing personalized routines for health and wellness; providing a website featuring information in the field of health and wellness*" in Class 044, and all goodwill associated therewith (hereinafter the "Mark") and Assignor merged with Assignee; and

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in and to the Mark, together with the goodwill of the business in connection with which the Mark is used, and Assignor desires to transfer all of its rights, title and interest in and to the Mark together with the goodwill to Assignee.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby transfers and assigns to Assignee its entire worldwide right, title and interest in and to the Mark, together with the goodwill of the business associated therewith, including all registrations and applications therefore, including without limitation those filed after the Effective date, as well as all renewals and extensions of registrations that are or may be

secured by Assignee, its successors, assigns or other legal representatives, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives.

This assignment shall inure to the benefit of, and be binding upon the parties, their successors and assigns.


