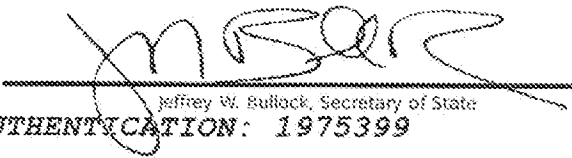

**THIRD:** The name of the surviving corporation is BAE Systems Information and Electronic Systems Integration Inc.

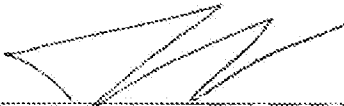

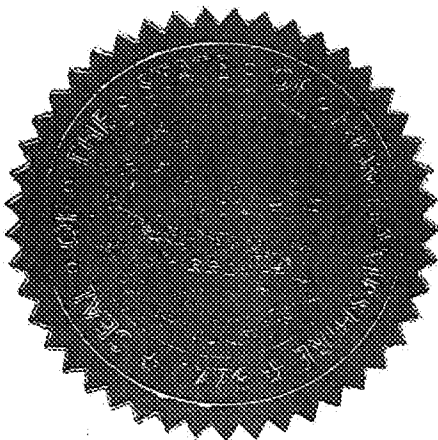
