TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 18, 2015 (this "Termination"), is made by CAPITAL BUSINESS CREDIT LLC, located at 11121 Carmel Commons Boulevard, Suite 270, Charlotte, NC 28226 ("CBC"), in favor of MK ACQUISITION, LLC, a Delaware limited liability company (successor in interest to Mountain Khakis, LLC), located at 1435 West Morehead, Suite 120, Charlotte, NC 28208 ("MK"). Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth in the Trademark Security Agreement referenced below.

WHEREAS, the Mountain Khakis, LLC, predecessor in interest to MK with respect to the Trademark Collateral, entered into that certain Trademark Security Agreement, dated as of September 15, 2008 (the "Trademark Security Agreement"), in favor of CBC;

WHEREAS, the Trademark Security Agreement was recorded in the records of the United States Trademark and Trademark Office on September 22, 2008 at Reel 3858 and Frame 0162;

WHEREAS, the obligations secured by the Trademark Collateral have been repaid in full; and

WHEREAS, CBC has agreed to terminate and release its security interest in all of the Trademark Collateral, including, without limitation, the trademarks identified on Schedule A attached hereto.


NOW, THEREFORE, in consideration of the provisions set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. CBC hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all security interests that it has in, to and under all Trademark Collateral.
2. Authorization to Record. CBC authorizes and requests that the United States Trademark and Trademark Office and any applicable government officer record this Termination.
3. Further Assurances. CBC shall take all further actions and provide to MK, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), reasonably requested by MK to more fully and effectively effectuate the purposes of this Termination, at MK's sole expense, and without representation or warranty by CBC.
4. Governing Law. This Termination shall be construed in accordance with and governed by the laws of the state of New York.
