NOW, THEREFORE, Assignor does hereby assign, transfer and convey unto Assignee Assignor's Interest in and to the Mark, and to the registration for the Mark, together with Assignor's Interest in the goodwill of the business symbolized by the Mark, including the right to sue and recover for any past infringement thereof.
