ASSIGNOR of the aforesaid MARK hereby agrees to waive all rights and privileges to attack the application/registration of the aforesaid MARK which ASSIGNOR has assigned as against anyone claiming a right under the aforementioned MARK under ASSIGNOR's assignment or grant.

ASSIGNOR warrants that it is the sole and exclusive owner of the MARK listed within this assignment, and that the MARK is free of all liens, security interests, claims or other encumbrances except where specifically noted.

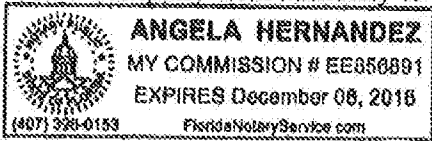
