TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of June 24, 2015, by FIFTH THIRD BANK, in its capacity as Administrative Agent (in such capacity, "Secured Party"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Old Hamilton Avenue Corp., a California corporation (f/k/a Medicine Made Easy) ("Grantor"), and Secured Party are parties to that certain Trademark Security Agreement dated as of December 19, 2013 (as the same has been, and may be further amended, modified and/or restated from time to time, the "Security Agreement") pursuant to which Grantor granted a security interest to Secured Party in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on January 14, 2010, at Reel 4131, Frame 0511;

WHEREAS, Grantor has requested that Secured Party release its security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Secured Party hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):


