ASSIGNMENT OF INTANGIBLE PROPERTY

The Assignment may be made of record in any government and/or administrative authorities, including in the United States Patent and Trademark Office, as appropriate and desired by Assignee.

No amendment, modification, waiver, replacement, termination, or cancellation of any provision of this Agreement will be valid, unless the same will be in writing and signed by Assignee and Assignor.

This Agreement and all disputes, claims or controversies relating to, arising out of, or in connection with this Assignment shall be governed by and construed in accordance with the internal Laws of the State of California without regard to the laws of any other jurisdiction that might be applied because of the conflicts of laws rules of the State of California.

This Assignment shall inure to the benefit of, and be binding upon, the successors, executors, administrators, legal representatives and assigns of Assignor and Assignee.

Assignor is executing and delivering this Assignment in accordance with and subject to all of the terms and provisions of the Agreement.
