SERVICEMARK ASSIGNMENT

This Servicemark Assignment, made and entered into this 27th day of May, 2015, by and between Paul's Auto Yard, Inc., an Indiana Corporation, located at 651 West State Road 2, P.O. Box 50, Westville, Indiana 46391-0050, hereinafter referred to as Paul's Auto Yard; and Bearfoot, Inc., an Indiana Corporation, located at P.O. Box 50, Westville, Indiana 46391, hereinafter referred to as Bearfoot.

WHEREAS, Paul's Auto Yard is the owner of select servicemark rights upon the servicemark MUD PATROL, Reg. No. 1,892,387, registered on April 17, 2012, and desires to assign said registration to Bearfoot; and Bearfoot is desirous of acquiring all of said right, title and interest in and to said servicemark registration, as currently held by Paul's Auto Yard.

Therefore, in consideration of the sum of one dollar (\$1.00), paid by Bearfoot to Paul's Auto Yard, the receipt of which is hereby acknowledged Paul's Auto Yard does hereby sell and assign to said Bearfoot all of its right, title and interest in and to said servicemark registration upon MUDPATROL, the same to be held and enjoyed by Bearfoot to the full end of the terms for which said servicemark has been registered, as fully and entirely as the same would have been held and enjoyed by Paul's Auto Yard, if this assignment and sale had not been made; the assignment of said servicemark and its registration includes the transfer and assignment of the said servicemark, its registration, and the goodwill symbolized by the mark as used upon the identified service in commerce, so that Bearfoot obtains the full and exclusive rights to the statutory servicemark registration, and any common law rights incident thereto, pertaining to the servicemark being assigned herein; and, included in the assignment of the servicemark, and its registration, is the right of Bearfoot to initiate and prosecute any suit for servicemark infringement, that may have occurred prior to the date of execution of this assignment, and to recover and retain any damages sustained as a result of any said infringement or unfair competition perpetrated by others.
