Assignment

Date: 24th April 2015

Parties:

- (1) "The Assignor": Suzanne Michele Taylor, a New Zealand National, of 9A Sayegh Street, St. Heliers, Auckland, New Zealand.
- (2) "The Assignee": HI-SPEC (FAREHAM) LIMITED, a company (Registration No. 04533740) registered under the laws of England and Wales, of The Old Surgery, The Drovc, High Street, Southwick, Hampshire PO10 6EB, United Kingdom.

Recitals:

- (A) The Assignor is the registered proprietor of the UK, Community and US Registered Trade Marks particulars of which are set out in Schedule 1 below hereto ('the Trade Marks').
- (B) The Assignor has agreed to assign to the Assignee the Trade Marks together with the goodwill of the business of the Assignor concerned in the goods in respect of which the Trade Marks are registered upon the following terms and conditions.

Operative provisions:

1 Assignment

In pursuance of the said agreement and in consideration of the sum of £16,000 pounds sterling now paid by the Assignee to the Assignor (the receipt whereof the Assignor hereby acknowledges) the Assignor with full title guarantee HEREBY ASSIGNS unto the Assignee the Trade Marks and the full and exclusive benefit of them together with the goodwill of the business of the Assignor concerned in the goods or services in respect of which the Trade Marks are registered TO HOLD the same unto the Assignee absolutely.

2 Assignor's obligations and warranties

- 2.1 The Assignor shall at the discretion and expense of the Assignee execute any further document and do any such thing as the Assignee may require to enable the Assignee to become registered as proprietor of the Trade Marks and to secure the benefits of the rights hereby assigned.
- 2.2 The Assignor hereby warrants that:
 - 2.2.1 it is the proprietor of the Trade Mark and has the full power to enter into this Assignment;
 - 2.2.2 it has not granted any licences to use the Trade Marks;
 - 2.2.3 it has not, either by act or omission caused and permitted anything to be done which might endanger the validity of the Trade Mark or the ability of the Assignee to register this Assignment;
 - 2.2.4 it has not knowingly withheld from the Assignee knowledge of any circumstances that might endanger the validity of the Trade Marks or the ability of the Assignee to register this Assignment.

2.3 The Assignor hereby agrees to indemnify, and to keep the Assignee indemnified, against all actions claims proceedings costs and damages (including any damages or compensation paid by the Assignee on the advice of its legal advisors to compromise or settle any claim) and all legal costs and other expenses arising out of any breach of the warranties in clause 2.2 or out of any claims by a third party based on any facts which if substantiated would constitute such a breach.

3 The amount stated in this Deed to be payable by the Assignee to the Assignor is exclusive of value added tax ("VAT") which shall be payable by the Assignee and the Assignor shall deliver to the Assignee upon request a proper VAT invoice for the amount (if any) of VAT chargeable.
