TRADEMARK ASSIGNMENT

Assignor hereby grants, conveys, sells, assigns, transfers, and delivers to Assignee all right, title, and interest in and to the Trademark, together with (a) the good will of the Business symbolized by the Trademark and the registration therefor, (b) all income, royalties, and damages that become due or payable to Assignor with respect to the Trademark, including damages and payments for past or future infringements and misappropriations of the Trademark, and (c) all rights to sue for past, present, and future infringements or misappropriations of the Trademark.
