SCHEDULE 4

DEED OF ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

THIS DEED OF ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS IS MADE THE 28th DAY OF FEBRUARY 2015 BY:

- 1 **HOUSE AND GARDEN B.V.**, a private company with limited liability (*besloten vennootschap met beperkte aansprakelijkheid*), incorporated under the laws of the Netherlands, having its corporate seat (*statutaire zetel*) in Almere, the Netherlands, and its office address at Bolderweg 28, 1332 AV Almere, the Netherlands, registered with the Dutch commercial register under number 34086370 ("**Assignor**"); and
- 2 Allied Imports & Logistics, Inc, a company incorporated and existing under the laws of the United States of America, having its its business office at 4122 Napier St, San Diego, CA 92110 (United States of America), registered under number 2592850 ("**Assignee**");

the parties set out above are hereinafter jointly referred to as the "**Parties**";

WHEREAS:

- (A) Assignor, acting as seller, and Assignee, acting as purchaser, have entered into a sale and purchase agreement dated 28 February 2015 (the "**Agreement**");
- (B) Parties now wish to complete the transactions contemplated by the Agreement by assigning the Intellectual Property Rights (as defined in the Agreement);
- (C) Parties now therefore wish to enter into this deed of assignment ("**Deed**");

HAVE AGREED AS FOLLOWS:

- 1 **Assignment**
 - 1.1 Assignor herewith assigns (*levert*) all right, title and interest in the Intellectual Property Rights to Assignee, whereas Assignee herewith accepts the same.
 - 1.2 The assignment includes, as the case may be, the right to sue for damages and other remedies in respect of any infringements of the Intellectual Property Rights, which may have occurred prior to the date hereof.

- 1.3 In so far as the Intellectual Property Rights are non-assignable, Assignor herewith, to the extent permitted by law, renounces and waives all rights and claims relating to the Intellectual Property Rights.

2 Execution of documents

- 2.1 Assignee shall, and is hereby authorized to, (i) cause the assignment of the Intellectual Property Rights to be duly recorded in the appropriate registers, and (ii) give such notices and perform such further acts as may be necessary to cause the assignment to have full force and effect.
- 2.2 To the extent that the authority provided to Assignee under clause 2.1 of this Deed is not sufficient to enable Assignee to cause the assignment to have full force and effect, Assignor shall, at the reasonable request of Assignee, cooperate with the execution of all further documents and shall perform all further acts as may be necessary to cause the assignment to have such full force and effect.

3 Waiver

Parties hereto waive their right to dissolve (*ontbinden*) or annul (*vernietigen*), or to demand dissolution or annulment (*in rechte ontbinding of vernietiging vorderen*) of this Deed in whole or in part.

4 Costs

- 4.1 Assignee shall pay all costs with respect to (i) the recording of the assignment of the Intellectual Property Rights in the appropriate registers, and (ii) the performance by Assignor of its obligations under Clause 2.2.
- 4.2 Parties agree that, except as provided in Clause 4.1, each Party shall bear its own costs with respect to the preparation and execution of this Deed.

5 Miscellaneous

- 5.1 In the event that any provision of this Deed proves to be non-binding, the other provisions of this Deed shall continue to be effective. The parties are obliged to replace the non-binding clause with another clause that is binding, in such manner that the new provision differs as little as possible from the non-binding clause, taking into account the object and the purpose of this Deed and the non-binding clause.
- 5.2 This Deed may be signed in any number of counterparts, each of which shall be an original, but only all of which, when taken together, shall constitute one and the same document.



6 Applicable law and settlement of disputes

- 6.1 This Deed and any agreement resulting here from is construed under and shall be governed by Dutch law.
- 6.2 All disputes arising out of or in connection with this Deed, or any agreement resulting there from, which cannot be settled amicably, shall be finally settled in accordance with the Arbitration Rules of The Netherlands Arbitration Institute (*Nederlands Arbitrage Instituut*). The arbitral tribunal shall be composed of three arbitrators. The arbitrators shall decide in accordance with the rules of law. The place of arbitration shall be Amsterdam (the Netherlands). The arbitral procedure shall be conducted in the English language. Consolidation of the arbitral proceedings with other arbitral proceedings pending in the Netherlands, as provided in art. 1046 of The Dutch Code of Civil Procedure, is excluded. The arbitral award shall not be made public.


