TERMINATION AND RELEASE OF SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF SECURITY AGREEMENT** ("Release"), dated as of July 20, 2015, is made by **YOGITOES, INC.** (the "Secured Party"), a California corporation and **YOGITOES, LLC**, a Delaware limited liability company ("Pledgor").

WHEREAS, pursuant to the terms of the Security Agreement dated as of July 9, 2013, between the Secured Party on one hand, and Pledgor on the other, and recorded with the United States Patent and Trademark Office on July 17, 2013 at Reel/Frame 5072/0759 for the purpose of securing certain obligations of the Pledgor to the Secured Party, the Pledgor granted to the Secured Party a security interest in and lien on the intellectual property identified on Schedule A attached hereto (such trademarks referred to herein as the "Trademarks"); and

WHEREAS, the Administrative Agent wishes to hereby terminate and release its security interest in each of the Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party and the Pledgor hereby agree as follows:

1. **Release**. The Secured Party hereby terminates and releases its security interest in and lien on all of the Trademarks.

2. **Further Assurances**. The Secured Party hereby authorizes the Pledgor or the Pledgor's authorized representative(s) to record this Release. The Secured Party further agrees to execute and deliver to the Pledgor any and all further documents and instruments and to do any and all further acts which the Pledgor, or its agents or designees reasonably request, at the Pledgor's sole cost and expense, in order to confirm this Release and the Pledgor's right, title and interest in, to and under the Trademarks.

IN WITNESS WHEREOF, Yogitoes, Inc. has hereby executed this Release to take effect as of the date first set forth above.
