RELEASE OF TRADEMARK SECURITY AGREEMENTS

THIS RELEASE OF TRADEMARK SECURITY AGREEMENTS (the "Release") is made on this 24th day of July, 2015 by Bank of Montreal, in its capacity as administrative agent for a group of lenders (in such capacity, the "Administrative Agent").

WHEREAS, pursuant to (i) that certain Pledge and Security Agreement dated of as December 5, 2012, among American Surgical Assistants, Inc., a Texas corporation (the "Grantor") and Administrative Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement"), (ii) that certain Trademark Security Agreement dated December 5, 2012, among the Grantor and Administrative Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), and (iii) that certain Trademark Security Agreement dated April 24, 2014, among the Grantor and Administrative Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Additional Trademark Security Agreement"; and together with the Trademark Security Agreement, the "Trademark Security Agreements"; and the Trademark Security Agreements, together with the Pledge and Security Agreement, the "Security Instruments"), the Grantor granted to the Administrative Agent a security interest in certain Trademarks (as defined in the Trademark Security Agreements). Capitalized terms used herein but not otherwise defined shall have the meaning given such terms in the Trademark Security Agreements;

WHEREAS, the security interest granted to the Administrative Agent was recorded at the United States Patent and Trademark Office on (i) December 5, 2012 at Reel 004913 and Frame 0124, and (ii) April 24, 2014 at Reel 005267 and Frame 0632; and

WHEREAS, the Administrative Agent has agreed to terminate and release all of its interest in and to all of the Collateral (as defined in the Trademark Security Agreements).


