## INTELLECTUAL PROPERTY SECURITY AGREEMENT

**Intellectual Property Security Agreement**, dated as of July 17, 2015 made by **FARMERS EDGE INC.** (together with its successors, the "**Debtor**"), successor by amalgamation to **FARMER'S EDGE PRECISION CONSULTING INC.**, in favour of **OSMINGTON INC.** (together with its successors and assigns, the "**Secured Party**").

WHEREAS, the Debtor and the Secured Party are parties to a secured convertible debenture dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Debenture**") pursuant to which the Debtor has granted to the Secured Party a security interest in all of its right, title and interest in, to and under, among other property, certain intellectual property of the Debtor as security for the timely payment or performance of the Obligations (as defined in the Debenture);

WHEREAS, the Debtor has agreed to execute this Intellectual Property Security Agreement for recording with the United States Patent and Trademark Office and/or the United States Copyright Office, as applicable;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and to induce the Secured Party to enter into the Debenture, the Debtor hereby agrees with the Secured Party as follows:

1. Defined Terms. Unless otherwise defined herein, terms defined in the Debenture and used herein have the meaning given to them in the Debenture.
2. Grant of Security Interest in Intellectual Property Collateral. As continuing security for the payment and performance of each of the Obligations, the Debtor hereby pledges and grants to the Secured Party a lien on and security interest in and to all of its right, title and interest in, to and under all the following collateral of such Debtor:
  - (a) the Copyrights listed on Schedule "A" attached hereto;
  - (b) the Trade-marks listed on Schedule "B" attached hereto;
  - (c) the patents listed on Schedule "C" attached hereto; and
  - (d) all other Intellectual Property of the Debtor(collectively, the "**Collateral**").
3. Security Agreement. The security interests granted pursuant to this Intellectual Property Security Agreement are granted in conjunction with the security interest granted to the Secured Party pursuant to the Debenture and the Debtor hereby acknowledges and affirms that the rights and remedies of the Secured Party with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Debenture, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Intellectual Property Security Agreement is deemed to conflict with the Debenture, the provisions of the Debenture shall control unless the Secured Party shall otherwise determine.

4. Termination. Upon the payment in full of the Obligations and termination of the Debenture, the Secured Party shall execute, acknowledge, and deliver to the Debtor an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Collateral under this Intellectual Property Security Agreement and agrees to deliver such further and other documents as may be required to release the Secured Party's interest in and to the Collateral and properly record same at the United States Patent and Trademark Office and/or the United States Copyright Office, as applicable or any other applicable intellectual property office.
5. Counterparts. This Intellectual Property Security Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Intellectual Property Security Agreement by signing and delivering one or more counterparts.
6. Governing Law. This Intellectual Property Security Agreement shall be governed by and construed in accordance with the laws of the Province of Manitoba and the federal laws of Canada applicable in the Province of Manitoba.


