## TRADEMARK ASSIGNMENT

**NOW THEREFORE**, in consideration of the sum of Ten Dollars, the terms and conditions herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, hereby agree as follows:

1.     **Assignment**. Assignor does hereby assign and transfer to Assignee, its successors and assigns, all of its right, title, and interest, in the United States of America, in, to and under said Trademarks, including but not limited to all goodwill associated therewith, and all past, present and future income, royalties, fees, damages, and payments now or hereafter due or payable in respect thereto, and in and to any and all past, present and future causes of action (either in law or in equity), and the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement or misappropriation of the Trademarks.




the Trademarks pertain and that Assignor no longer has any right, title or interest, of any kind or nature, in or to the Trademarks.
