## **PARTIAL TRADEMARK RELEASE**

THIS PARTIAL TRADEMARK RELEASE is made as of July 21, 2015, by Fifth Street Finance Corp., as collateral agent for the lenders (in such capacity, "Collateral Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

### WITNESSETH:

WHEREAS, Crealta Pharmaceuticals LLC, a Delaware limited liability company ("Grantor") and Collateral Agent were parties to that certain Trademark Security Agreement dated as of February 21, 2014 (the "Security Agreement"), pursuant to which Grantor granted a security interest to Collateral Agent in certain trademarks set forth on Schedule 1 hereto ("Trademarks") as security for certain obligations owing by Grantor to Collateral Agent; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 5, 2014, at Reel 05229, Frame 0060; and

WHEREAS, Grantor has requested that Collateral Agent release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademarks.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged by the parties to the Security Agreement:

1. Collateral Agent hereby releases, for itself and on behalf of the lenders, its security interest in and lien on all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

- (a) each Trademark set forth on Schedule 1 hereto,
- (b) all renewals and extensions of the Trademarks;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the Trademarks, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.
