**NOW, THEREFORE, BE IT KNOWN** that, for and in consideration of the sum of One Dollar (\$1.00) in hand paid, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said Assignor has sold, assigned,

and transferred, and by these presents does hereby sell, assign and transfer, *nunc pro tunc* effective December 15, 2012, to said Assignee, the entire right, title and interest of Assignor in and to the said Trademark and/or any registrations that have been, or may be, issued for the Trademark in the U.S. and in any foreign countries, and in and to any renewals that have been, or may be, granted thereon, together with the goodwill of the business connected therewith and any right to recover for past infringement thereof.
