## SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

This Supplement to Trademark Security Agreement (this “*Supplement*”) is made as of the 24<sup>th</sup> day of August, 2015 by **ELMHURST DAIRY, INC.**, a New York corporation (“*Grantor*”), in favor of Rockland Trust Company, as administrative agent (in such capacity, together with its successors and permitted assigns, “*Grantee*”) for certain lenders.

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks dated as of November 24, 2014 and recorded on May 22, 2015 at Reel 005522, Frame 0547 (as amended and of record from time to time hereinafter, the “*Grant*”) in favor of the Grantee, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Marks (as defined therein).

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
