RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of August 31, 2015 (this “Release”), by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Administrative Agent and Collateral Agent (in such capacities, the “Agent”), in favor of CAPELLA HEALTHCARE, INC., a Delaware corporation (the “Borrower”), MUSKOGEE REGIONAL MEDICAL CENTER, LLC, a Delaware limited liability company and WILLAMETTE VALLEY MEDICAL CENTER, LLC, a Delaware limited liability company (each, a “Grantor” and collectively the “Grantors”). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of December 31, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among the Borrower, Capella Holdings, Inc. (“Holdings”), the lenders from time to time party thereto and the Agent, (ii) the Security Agreement dated as of December 31, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) among the Borrower, Holdings, the subsidiaries of the Borrower party thereto and Credit Suisse AG, Cayman Islands Branch, as Collateral Agent (in such capacity, the “Collateral Agent”), and (iii) the Grant of Security Interest in United States Trademarks dated as of December 31, 2014, among the Grantors and the Collateral Agent (such documents set forth in clauses (i) through (iii), the “Security Documents”).

B. Pursuant to the Security Documents, the Grantors granted to the Collateral Agent a security interest in all right, title and interest of the Grantors in, among other things, the Trademarks set forth on Schedule I hereto (the “Trademark Collateral”), which security interest was recorded with the United States Patent and Trademark Office on December 31, 2014 at Reel 5433, Frame 0106.

C. Pursuant to the Payoff Letter dated as of August 31, 2015 among Borrower, Holdings and the Agent, the Agent agreed to release any and all interests it may have in the Trademark Collateral.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby terminate, release, relinquish and discharge its security interest in the Trademark Collateral and any right, title or interest it has in the Trademark Collateral shall hereby cease and become void. This Release is made without representation or warranty by, or recourse to, the Agent or any other Secured Creditor.


