Assignment of Trademarks

This Assignment of Trademarks ("Assignment Agreement") is made effective as of August 28, 2015 ("Effective Date"), by and between Probus Media Group, Inc., a Pennsylvania corporation (the "Assignor"), and iQ Media Group LLC, a Pennsylvania limited liability company ("Assignee").

WHEREAS, Assignor previously registered certain trademarks specified on Exhibit A hereto and desires to assign, transfer, sell and convey to Assignee the whole and entire title, rights, interests, benefits and privileges of Assignor in and to such trademarks owned or purported to be owned by Assignor (collectively, the "Assigned Trademarks").

NOW, THEREFORE, for One Dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, Assignor hereby, without reservation:

1. Assigns, transfers, sells and conveys, and confirms that Assignor has assigned, transferred, sold and conveyed to Assignee the whole and entire right, title and interest in and to the Assigned Trademarks, including all goodwill associated therewith, and the right to sue for and the remedies resulting from past and future infringement of the foregoing, and rights of protection of interest therein under the laws of all jurisdictions,

2. Authorizes and requests the Commissioner for Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all Assigned Trademarks to Assignee, as assignee of the whole and entire right, title and interest therein or otherwise as Assignee may direct.

3. Covenants, agrees and undertakes to execute, wherever requested by the Assignee, all assignments, lawful oaths and any other papers which Assignee may deem necessary or desirable for securing to Assignee or for maintaining for Assignee any and all of the Assigned Trademarks, all without further compensation to the Assignor.

4. Agrees that Assignor is hereby legally bound, upon request and at the expense of Assignee or its successors or assigns or a legal representative thereof, to supply all information and evidence of which Assignor has knowledge or possession relating to the Assigned Trademarks (and the business identified by the Assigned Trademarks), and to provide testimony in any legal proceeding relating thereto.

5. Represents and warrants that (i) Assignor has full right, power and authority to assign Assignor's whole and entire right, title and interest in and to the Assigned Trademarks, and to consummate the assignment contemplated herein, and (ii) Assignor has full right, power, and authority to enter into, execute and deliver this Assignment Agreement, the execution and delivery of which have been duly authorized by all necessary action on the part of Assignor and (iii) no other authorization or proceedings on the part of Assignor are necessary to authorize this assignment.

6. Counterparts and Amendment. This Assignment Agreement may be executed in counterparts and via facsimile signatures, each of which will be deemed an original, but all of which together constitute one and the same original. This Assignment Agreement may not be amended except by an instrument in writing signed by each of the parties hereto. This Assignment Agreement shall inure to the benefit of, and be binding upon, the successors, assigns, heirs, or legal representatives of the parties hereto.
