2. ASSIGNOR hereby authorizes the Canadian Intellectual Property Office, the United States Patent and Trademark Office, and the empowered officials of all other governments to issue or transfer all Assigned Trademarks to Assignee, as assignee thereof, or otherwise as Assignee may direct.
3. Assignor further agrees, from time to time, to make, do, and execute, or cause to be made, done, or executed all such further acts, deeds, assurances, or things that may reasonably be required to give effect to the foregoing provisions.




