WHEREAS:

A. The Assignor is the sole owner of all right, title and interest in and to the trade-mark and the corresponding registration set forth below (the "Trade-mark"), together with the goodwill of the business with, and symbolized by, the Trade-mark:

B. The Assignee wishes to acquire all right, title and interest in and to the Trade-mark.

NOW, THEREFORE, for good and valuable consideration (the receipt and sufficiency of which are hereby acknowledged), the parties agree as follows:

1. The Assignor as the sole owner hereby assigns and transfers unto the Assignee the entire right, title and interest in and to:

- (a) the Trade-mark;
- (b) all of the benefit of the Trade-mark and all of the benefit of any use of the Trade-mark and the goodwill of the business relating to the Trade-mark and to the wares and services associated with the Trade-mark;
- (c) all income, royalties, damages and payments now and/or in the future due and/or payable in connection with the Trade-mark, including, without limitation, damages and payments for past and future infringements of the Trade-mark; and
- (d) the right to sue for past, present and future infringements of the Trade-mark in any jurisdiction worldwide.

2. The Assignor hereby authorizes the Register of Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by the Assignee. Following the date hereof, upon the Assignee's request, the Assignor shall take such steps and actions, and provide such cooperation and assistance to the Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence or perfect the assignment of the Trade-mark to the Assignee, or any assignee or successor thereof.
3. Notwithstanding any other provision hereof, this Assignment shall be governed by, and construed in accordance with, the laws of the United States of America and the State of California without reference to the choice of law principles thereof. Each party hereby agrees to the non-exclusive jurisdiction of the state and federal courts of the State of California and irrevocably submits to the non-exclusive jurisdiction of such courts.
4. This Assignment shall be binding upon the Assignor and its successors and shall enure to the benefit of the Assignee and its successors, assigns and licensees.
5. This Assignment may be executed in counterparts, each of which shall be deemed to be an original and all of which together shall be considered one and the same agreement. A signed facsimile or electronically transmitted copy of this Assignment shall be effectual and valid proof of execution and delivery.
