TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made and entered into as of September 9, 2015 ("Effective Date"), by and between SEHL PRODUCTIONS, INC. d/b/a BRITE CONCEPTS, a Minnesota corporation with an address of 2580 Hadley Valley RD NE Rochester, MN (along with its predecessors and related parties, Michael Sehl and Brite Concepts Inc., "Assignor"), and LAMI PRODUCTS, INC., a Pennsylvania corporation with an address of 860 Welsh Road, Huntingdon Valley, PA 19006 ("Assignee"). Each of the Assignor and Assignee are herein referred to individually as a "Party" and together as the "Parties."

BACKGROUND

A. Assignee engaged Assignor to perform certain services in connection with the development, sourcing, and manufacturing of certain products, during which engagement Assignor registered and applied to register certain trademarks in Assignor's name, as set forth in Schedule 1 attached hereto and made a part hereof (collectively, the "Assigned Trademarks");

B. Pursuant to a Supply Agreement between, *inter alia*, the Parties dated [], Assignor assigned, transferred and conveyed all worldwide right, title and interest in, to and under certain intellectual property, including; and

C. The Parties desire to memorialize Assignee's ownership of the Assigned Trademarks and formally record such ownership with the United States Patent and Trademark Office and any other public records for which recording is deemed appropriate by Assignee.

TERMS

1. **Assignment.** For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby unconditionally and irrevocably assigns, transfers and conveys to Assignee and confirms that it did unconditionally and irrevocably assign, transfer and convey to Assignee, its successors and assigns, all of its right, title, and interest, throughout the world, in, to, and under the Assigned Trademarks and all registrations and applications for registration thereof and all common law rights with respect thereto together with all goodwill of the business in which the mark is used and which is symbolized by the Assigned Trademarks, including, but not limited to, all benefits, privileges, causes of action, and remedies relating to such Assigned Trademarks, including, without limitation, the exclusive rights to (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) all rights and causes of action to recover past, present and future damages, royalties, fees, profits and other relief including, but not limited to, equitable and injunctive relief ensuing from past, present and future infringement of the Assigned Trademarks, (c) grant licenses or other interests therein and (d) otherwise fully and entirely stand in the place of Assignor in all matters related thereto.

2. **Further Assurances.** Assignor shall execute any instruments or documents and perform all other acts necessary or appropriate, in the reasonable discretion of the Assignee, to further evidence the intent and purpose of this Assignment.

3. **Counterparts.** This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile, portable document format or other electronic means shall be effective as delivery of a manually executed counterpart to this Assignment.
