WHEREAS, Assignor is the owner of all right, title and interest, including, without limitation, common law trademark rights, in and to the trade names, logos, trademarks, service marks and other designations of origin containing the term "MOMMY MADE" used in connection with the business of Assignor, including, without limitation, the MOMMY MADE® service mark and related federal registration in the United States therefor (Registration No. 4,621,396 dated October 14, 2014) for use in connection with "Online retail store services featuring downloadable music files, video files, and computer software applications" in International Class 35 (the "Mark");

WHEREAS, Assignee desires to acquire all right, title, and interest, and all goodwill associated therewith, in and to the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties intending to be legally bound, hereby agree as follows:

1. Assignor does hereby assign and transfer to Assignee, all right, title and interest in and to the Mark, together with all goodwill symbolized by and associated with said Mark, including all registrations therefor and all common law rights therein; and any and in and to any and all causes of action (either in law or in equity), as well as the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement, misappropriation and/or dilution of the Mark.
2. Assignor hereby agrees to execute, acknowledge and deliver any and all documents and to take such other and further actions as are reasonably necessary to transfer and assign the Mark to Assignee, and to make a record of such assignment, including, without limitation, recording this Assignment with the United States Patent and Trademark Office.
