**DECLARATION IN SUPPORT OF CORRECTIVE ASSIGNMENT**

On December 16, 2011, an assignment was recorded at Reel/Frame #4680/0913 in connection with Reg. Nos. 1522218 and 1522465. This assignment named the Assignor as "Charmant Kabushiki Kaisha, a Japanese limited liability company having offices at 6-5 Kawasari-cho, Sabae-shi, Fuki-Ken 916-8555, Japan". There were certain errors in the name and address of the Assignor.

First, the Japanese wording "Kabushiki Kaisha" in the name of the Assignor is actually translated into English as "Inc.", therefore, the name of the Assignor should have been noted as "Charmant Inc." - which is the name of the entity that actually executed the referenced assignment recorded at Reel/Frame #4680/0913.


Second, the entity type of the Assignor should be listed as a "corporation", not a "limited liability company".

Third, the house number in Assignor's address should be "6-1", not "6-5".

Fourth, the prefecture in Assignor's address should be "Fukui-ken", not "Fuki-Ken".


